Department of Neighborhood Empowerment 10:39 AM

DONE General Manager, Raquel Beltran gave her report. She shared items that involve general updates about the department and the budget. She addressed the letter sent to her about the meeting that involved CD8 and would dedicate more time to that at the meeting that will be scheduled for it.

Other topics included:

- EBG Page: She encouraged people to listen to the audio files on the page;
- Roberts Rules Made Simple: DONE purchased a license and it's available for review.
- Encouraged that people be recognized by the Chair before they speak.
- Budget cut: A 3% Budget cut, and there will be no new programs, and staffing. Vacancies for jobs stayed vacant.
- Forming Alliance: Councils have this right to form alliances (e.g. Emergency Preparedness Services).
- Grievance Panel: A Council Ordinance was approved and codified. Each Council in the ordinance can ID a person they recommend to serve on a regional panel. The final decision about who is theirs.

LAPD Report 11:16 PM

Senior Lead Officer, Gary Verge of the 77th Division gave his report and an overview of the crimes related to shootings, robberies and burglaries in the area he covers. He also reported that his department had 105 Officers who contracted Covid and two deaths, and citywide there were a total of 2100 Officers who contracted Covid resulting in reduced their resources.

Other topics included:

- Zoom Town Hall on February 24 at 6pm. Vice-President Alison McBeth-Featherstone agreed to share the information.
- CalGang System: They no longer enter anyone into this system.

Senior Lead Officer, Paul Evleth of the Southwest Division shared his screen regarding the Oscar Joel Bryant Foundation and an online event February 20 at 9:30am. He encouraged attendance as it promotes the hiring of more African American police officers.

Other Topics Included:

- CrimeStoppers.org: This allows stakeholders to anonymously provide crime tips.
- Homicide at Crenshaw / Vernon: 34-Year-old male shot in his car. He asked anyone who knows anything to report it.

City Council Marqueece-Harris Dawson (CD8) 11:53 PM

Field Deputy, Dina Andrews provided many updates in the district. She reported on the COVID-19 vaccination pop up, and clarified that they are for 65 and over, and healthcare workers. She addressed certain concerns about the Afiba Center.
